

**RESOLUTION 2019-183**

**AWARDING A CONTRACT TO SEACOAST CONSTRUCTION, INC.  
FOR NJDOT 2019 MUNICIPAL AID OCEAN GATE AVENUE CURB  
AND SIDEWALK REPAIR – PHASE 2 PROJECT**

**WHEREAS**, the Borough of Ocean Gate (hereinafter the “Borough”), County of Ocean, State of New Jersey, advertised for bids in accordance with Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., for the NJDOT 2019 Municipal Aid Ocean Gate Avenue Curb and Sidewalk Repair Phase 2 Project; and

**WHEREAS**, three (3) bids were received and opened by the Borough on August 28, 2019; and

**WHEREAS**, Seacoast Construction, Inc., 15 Addington Court, East Brunswick, New Jersey 08816, submitted the low bid in the amount of \$190,963.00; and

**WHEREAS**, two (2) other bids were received that ranged from \$219,715.43 to \$260,550.00; and

**WHEREAS**, the Borough Attorney and Municipal Engineer reviewed the bids and determined that Seacoast Construction, Inc., 15 Addington Court, East Brunswick, New Jersey 08816, submitted the lowest responsible bid in accordance with the solicitation; and

**WHEREAS**, the Borough Chief Financial Officer provided a copy of the certification of available funds to the Borough Council; and

**WHEREAS**, the Borough Council reviewed the certification of available funds and recommendations made by the Borough Attorney and Municipal Engineer on said bid; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Ocean Gate, County of Ocean, State of New Jersey, that the contract for the NJDOT 2019 Municipal Aid Ocean Gate Avenue Curb and Sidewalk Repair Phase 2 Project is hereby awarded to Seacoast Construction, Inc. as the lowest responsible bid in the amount of \$190,963.00.

**BE IT FURTHER RESOLVED**, that award of this contract is to be allocated from the Grant Fund – NJDOT 2019 Municipal Aid Ocean Gate Avenue Curb and Sidewalk Project; and

**BE IT FURTHER RESOLVED**, that the maximum dollar value for this project is \$190,963.00; and

**BE IT FURTHER RESOLVED**, that the Mayor and Clerk are authorized and directed to execute a contract and any required supplemental documents on behalf of the Borough of Ocean Gate; and

**BE IT FURTHER RESOLVED**, that the Municipal Clerk is hereby authorized, upon receipt of fully executed contract and any other required documents, to return the certified checks or bid bonds of the following bidders:


