**RESOLUTION OF THE BOROUGH OF OCEAN GATE,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AWARDING A CONTRACT TO SEACOAST
CONSTRUCTION, INC. FOR 2019 CDBG ANGLESEA AVE
ADA CURB RAMPS AND GAZEBO RAISING PROJECT**

WHEREAS, the Borough of Ocean Gate (hereinafter the “Borough”), County of Ocean, State of New Jersey, advertised for bids in accordance with Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., for the 2019 CDBG Anglesea Avenue ADA Curb Ramps and Gazebo Raising Project; and

WHEREAS, three (3) bids were received and opened by the Borough on August 4, 2020; and

WHEREAS, Seacoast Construction, Inc., 15 Addington Court, East Brunswick, New Jersey 08816, submitted the low bid in the amount of \$94,700.15; and

WHEREAS, two (2) other bids were received that ranged from \$97,690.00 to \$153,788.00; and

WHEREAS, the Borough Attorney and Municipal Engineer reviewed the bids and determined that Seacoast Construction, Inc., 15 Addington Court, East Brunswick, New Jersey 08816, submitted the lowest responsible bid in accordance with the solicitation; and

WHEREAS, the Borough Attorney provided a copy of the certification of available funds to the Borough Council; and

WHEREAS, the Borough Council reviewed the certification of available funds and recommendations made by the Borough Attorney and Municipal Engineer on said bid; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Ocean Gate, County of Ocean, State of New Jersey, that the contract for the 2019 CDBG Anglesea Avenue ADA Curb Ramps and Gazebo Raising Project is hereby awarded to Earle Asphalt Company as the lowest responsible bid in the amount of \$94,700.15.

BE IT FURTHER RESOLVED, that award of this contract is to be allocated from _____; and

BE IT FURTHER RESOLVED, that the maximum dollar value for this project is 94,700.15; and

BE IT FURTHER RESOLVED, that the Mayor and Clerk are authorized and directed to execute a contract and any required supplemental documents on behalf of the Borough of Ocean Gate; and

BE IT FURTHER RESOLVED, that the Municipal Clerk is hereby authorized, upon receipt of fully executed contract and any other required documents, to return the certified checks or bid bonds of the following bidders:

2. Albert Marine Construction, Inc.; and
3. Abhzeen Design, Inc.
