Application Instructions Boat Mooring

You **must** provide the following with your application:

- 1) Current year copy of insurance policy that covers boat/ Homeowners acceptable if it lists the boat on endorsement to the policy
- 2) Current year copy of vessel registration
- 3) Picture of boat vessel (Requested)
- 4) Mooring apparatus must be made available for inspection by Code Enforcement Officer at location in the Borough. **Complete assembly must be present for inspection / To include mushroom or pyramid anchor, chain, buoy and swivels**

*** For the safety of all residents and visitors to the Borough of Ocean Gate, as well as for the safety of all boats used and moored in the waters within the Borough, no person shall moor or anchor a boat using submerged motors, flywheels, blocks or cement or concrete, tin cans or containers filled with concrete, or other such items as such anchor or mooring device.**

- 5) All fees shall be made payable to the "Borough of Ocean Gate"
- 6) Permit fees shall be \$2.00 per foot with a minimum fee of \$20.00
- 7) No boat over 19 feet shall be allowed on beach
- 8) The following locations are **prohibited** for the water or beach mooring of boats:
 - a. From Wildwood Avenue Pier to the easterly side of Stone Harbor Avenue
 - b. From Anglesea Avenue Pier easterly for a distance of 500 feet
 - c. From a point 50 feet west of Monmouth Avenue to a point 50 feet east of Monmouth Avenue
 - d. From the east Borough line westerly for a distance of 300 feet

When all items are provided and an inspection of the Mooring apparatus has been completed and approved a mooring permit will be issued.

Instructions Boat Mooring

All regulations listed below must be followed or a violation will be issued in the matter and summons issued if violation is not terminated.

If you have any questions call 732-269-3166 Ext 129

- 1) No vessel shall be permitted moored or beached from October 1 thru March 1 of the following year*
- 2) No boat in excess of 19 feet shall be stored upon the beach in the Borough or in a location within 8 feet of boardwalk or 4 feet to the high water line of the beach*
- 3) All MOORING ASSEMBLIES shall be removed by October 1st. If Mooring is not removed by this date a summons will be issued immediately. Summons will be issued on a weekly basis for violation. Any remaining mooring assemblies may be removed by the Borough at a charge of \$300.00 per mooring which will be assessed to the boat owner. This charge will have to be paid for return of the mooring apparatus before any other mooring permit can be issued. If the charge is not paid and the mooring apparatus not claimed within 90 days of removal and summons it will become the property of the Borough to dispose of as the Borough so determines.*
- 4) All boats/watercrafts/inflatable must be moored at least 100' from the low water mark on the beach to allow for the safety of the public and the use of the beach. Also this is imperative as the depth of the mooring apparatus must not be a detriment to navigation.*
- 5) Unloading and loading from the Borough piers shall be limited to one-half hour on the westerly side of each pier.*

Please note that ONLY boats/watercraft/inflatable vessels are permitted to be beached with proper stickers. Any other accessories (beach umbrellas, beach chairs, beach toys, etc.) must be removed as it can create a hazard. Thank you for your cooperation.

Prohibited Area: Water or Beach Mooring

- The following locations are prohibited for the water or beach mooring of boats:
- From Wildwood Avenue Pier to the easterly side of Stone Harbor Avenue
 - From Angelsea Avenue Pier easterly for a distance of 500 feet
 - From a point 50 feet west of Monmouth Avenue to a point 50 feet east of Monmouth Avenue
 - From the east Borough line westerly for a distance of 300 feet

All boats/watercrafts/inflatables must be moored at least 100 feet from the low water mark on the beach to allow for the safety of the public and the use of the beach. Also this is imperative as the depth of the mooring apparatus must not be a detriment to navigation.
